#### **GENERAL FINE SCHEDULE**

General:

1st-Warning

2nd- \$75 Fine

3rd- \$100 Fine

Each and subsequent violations- \$100 or more depending on notice from the Board



### CC&R's – Community Pets Pet Allowances

Hudson Trace only allows generally recognized household pets in each unit. Pets can weigh no more than 20 pounds each. Pet owners are solely responsible for all upkeep and care of their pets.

#### Pet Rules

Hudson Trace requires that all pets be leashed when in a common area. If a pet cannot be leashed, it should be carried. The pet should always be in human control when in a common area.

If a pet causes community damage or injury to another pet or human, the owner of the pet will be fined.

#### Pet Waste

Hudson Trace requires that all pet waste be cleaned up immediately. One of the most common forms of disease transmission between dogs is through fecal matter. Uncollected waste is also unattractive to the community and can be a health hazard to children.

When walking your pet, please take along a bag or use on of the community provided bags available throughout the complex. Pet waste can be disposed of in any of the community trash cans or pet waste stations located throughout the complex.

#### Pet Fine Schedule

1st- \$50 Fine (Please note, there is no warning for pet violations)

2nd- \$100 Fine

3rd- \$200 Fine

Please contact the management company should you see an animal(s) or owner(s) out of compliance with these Rules and Regulations. Please provide as much information about the animal as possible: including a description of the animal, as well as location of incident in the complex. #### **Covid-19 Safety**
